# **Lakeshore Nature Preserve Subcommittees**

Preserve Committee subcommittees are formed to provide an additional opportunity for discussion and the exploration and formulation of recommendations for Committee action. Subcommittee discussion is led by a member of the Preserve Committee and the meeting is facilitated by a Preserve staff member. Participation on the subcommittees is open to the public.

- **Planning and Implementation Subcommittee** reviews project proposals and special projects which arise from time to time.
  - 2015 planned activity: Subcommittee will need to meet between Nov. 3<sup>rd</sup> and Nov. 6<sup>th</sup> to review project proposals for recommendation at November meeting.
- **Education Subcommittee** facilitates the student engagement grant process including recommendation of selection of awardees.

- Oct-Feb: assist with outreach to inform students and faculty of student engagement grant program
- Feb: review grant proposals and rank applicants and report recommendations to Preserve Committee at March meeting

  Preserve website and migrating it to the Do-IT supported WiscWeb CMS system which will make
  creating and managing content easier and more efficient. Reviewers are needed to look at updated
