Facilities Planning & Management Preserve Staff Reports – October 24, 2018

DIRECTOR'S REPORT – Gary Brown, Director

There's a chill in the air that, I think, tells me it is fall! As our climate continues to change we are seeing interesting swings in both temperature and moisture this year. I'm happy to report that the Preserve soldiers on through these changes as we all try to manage change as best possible and be proactive where we can to avoid problems in the future. A good example ties back to the flooding rains we say in 2008 when after a heavy rain, the Class of 1918 Marsh, the Temin Path and the University Bay Drive fields were all inundated with high water. The university was proactive in finding the funding and providing measures to raise the Temin Path and University Bay Drive between Lake Mendota and the Class of 1918 Marsh. In doing, so we had minimal problems this past summer with all the rain in August when others were less fortunately than we here on campus. The high lake levels came within an inch of topping over the prior raised roads/paths. Good, long range planning is always important and implementing best practices in stormwater management have helped us here in the Preserve, especially on the west campus, mitigate our changing climate and rising lake levels. Do your part and help us all help the Preserve change for the good and be proactive in our planning.

CAPITAL PROJECTS - Rhonda James, Senior Landscape Architect

Capital Projects within the Preserve:

- MG&E will be forestry mowing brush under the power lines along Lake Mendota Drive in the space between the road and the Eagle Heights Community Gardens. Project could start anytime this fall.
- On the west edge of Eagle Heights Gardens, a portion of the access path/road will be regraded and the irrigation line protected.
- We are working on getting a sign at Frautschi Point. Similar to the one at Raymer's Cove.
- There will be a new memorial bench installed in Muir Woods this fall.
- At the City of Madison Well site, south of Frautschi Point and west of Biocore Prairie, the National Atmospheric Deposition Project is requesting to install research equipment. This is all on the City's easement and the city is participating in support for this research project.
- The bridge at the south end of the Class of 1918 Marsh remains closed.

LAND MANAGEMENT – Adam Gundlach - Field Projects Coordinator

- Eagle Heights Woods:
 - a. The trail water bar installation project with volunteers from Engineers for a Sustainable World student group was postponed due to rain.
 - b. Good Oak Ecological Services treated invasive brush resprouts across the Mound Zone and west slope.
 - c. We are planning North Zone brush removal for later this fall and into the winter months.
 - d. The Friends tour in Eagle Heights Woods has been rescheduled for October 21, 1-3pm.
- Bill's Woods porcelain berry control in west section.
- Trail maintenance removed downed trees from trails.
- Felled Norway maple trees logs used by FH King Gardens, and leaves collected by Currie Lab for leaf cutter ant colony winter forage.
- Picnic Point fire circle and wood rack maintenance.
- Prescribed burn planning for Lot 60 Swale, Eagle Heights Woods, Frautschi Point, and Biocore prairie areas 5 & 6.
- Homecoming preparations spit shine gathering spaces and main entry points.
- Sections of trail on Picnic Point have remained closed for much of the past month due to flood waters.

OUTREACH & VOLUNTEERS – Bryn Scriver, Outreach Specialist

Outreach activities:

- Short monthly submissions to the University Apartments newsletter have been completed.
- Coordinated outreach activity for UW Housing Sustain-A-Bash event Sept 28 with UW Arboretum staff and Preserve student and seasonal staff. Talked to approximately 75 students and engaged them in making seed balls.
- Homecoming Hot Chocolate on Picnic Point event advertised through postcard, email list, social media, kiosks, online calendars
- Along with Adam Gundlach, met with students in Wolves, Dogs, and People First Year Interest group. Gave overview of Preserve and answered student questions.
- Discussion with President of Hoofers Outing Club regarding field trip participation.
