It is not a land management plan, ecological restoration plan, or a long range facilities plan to guide or set priorities for capital improvement projects. These latter elements will all come after the strategic planning process is complete in late 2019 as an update to the 2006 Lakeshore Nature Preserve Master Plan. Thanks again for your commitment and engagement in making the Lakeshore Nature Preserve an amazing place for our many faculty, staff, students and visitors.

Capital Projects within the Preserve:

- MG&E is working to place the existing overhead power lines underground along Lake Mendota Drive west of the Eagle Heights Gardens. The poles will remain, at a shorter height, because overhead AT&T lines will be remaining on the poles.
- We are working on a replacement sign at Frautschi Point similar to the one at Raymer's Cove.
- We are also working on creating a low profile crossing of the bottom of the gully in Frautschi Point Woods.

Capital Projects adjacent to the Preserve:

• Lot 129/130 Parking Lot is scheduled for construction from June to September 2019. Please watch for upcoming updates about the detailed schedule and relocated parking opportunities during construction.

LAND MANAGEMENT - Adam Gundlach Field Projects Coordinator

- Eagle Heights Woods:
 - a. Worked with Wolfe Tree Service to remove hazard tree debris from the vicinity of the Indian mounds group, with the goal of connecting views across the mounds and improving prescribed fire implementation efficiency (less mop-up time).
- Processed seed collected in the Preserve in fall 2018. Compiled seed mixes from collected and purchased seed and sowed the seed mixes across roughly 7 acres of mixed habitats, focused mostly on recent brush removal areas and fall 2018 burn units – Raymer's Cove prairie, Frautschi Point, Biocore overlook (northeast corner shoreline), east savanna (old field), University Bay Drive swales, Lot 60, Willow Creek savanna and Willow Beach, and Picnic Point.
- Frautschi Point Burned brush piles from prior volunteer work.
- Completed Prairie Partners intern crew hiring process. The crew's first day working in the Preserve will be Thursday May 23.
- East savanna field Completed brush control (mostly sumac) along north edge and seeded with Biocore prairie seed collected in 2018.
- Submitted application for an AmeriCorps NCCC crew with UW Arboretum. If approved, the NCCC crew would work in the Preserve for two weeks in June 2019.
- Planning 2019 field work implementation logistics.
- Planning spring 2019 prescribed burn units. Will serve as a potential site for student volunteers from LA375 course to participate on burns, as required by the course.
